

RESOLUTION NO. 06-22

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF TAOS
DISPOSING OF CERTAIN MUNICIPAL PROPERTY**

WHEREAS, the Town of Taos own certain personal property which the Town is no longer in need of; and

WHEREAS, the Town has specifically identified such property as identified herein; and

WHEREAS, the Town believes it is in its best interest of the Town to dispose of said property pursuant to law.

NOW, THEREFORE, BE IT RESOLVED, by the Town Council of the Town of Taos:

The property identified herein is:

Unusable building materials located in building unit number 5

BE IT FURTHER RESOLVED that the property is:

1. of a current resale value of \$5000 (five thousand dollars) or less; and
2. worn-out, unusable or obsolete to the extent that the item is no longer economical or safe for continued use by the Town; and
3. the property shall be disposed of by the following method:
Potentially usable building materials shall be moved to another location for storage;
Obsolete or unusable materials shall be disposed of as ordinary waste and taken to the landfill.
